### **FEGLI Online Enrollment Now Available**

The Judiciary Benefits Center web site now offers online enrollment for the Federal Employees' Group Life Insurance (FEGLI) Program. We have posted an online user guide below for your reference with step-by-step instructions.

### ***Please note - 2013 Plan Year Changes:***

The IRS has announced an increase to both the Mass Transit and Parking benefit election limits for 2013. The new limit for both is now **\$245** per month.

The IRS has changed the allowable standard mileage rate when using a car or motorcycle to obtain medical care. Effective January 1, 2013, if you submit a claim for travel to and/or from health care providers, hospitals, pharmacies and other places that you receive eligible medical care, you will be reimbursed **24 cents per mile**.
